[1. \(1 point\) HB 940: \(2/1/12\) Handguns; eliminates prohibition on purchasing more than one in a 30-day period.](#)

[2. \(1 point\) HJ 3: \(2/13/13\) Constitutional amendment; taking or damaging of private property for public use \(second reference\).](#)

[3. \(1 point\) SB 1256: \(2/20/13\) Voter identification requirements; photo ID required at polls, application for absentee ballot.](#)

[4. \(1 point\) HB 1408: \(2/3/15\) Telecommunication records; warrant requirement, prohibition on collection by law enforcement.](#)

[5. \(1 point\) HB 1946: \(2/26/15\) Administrative subpoenas; electronic communication services. \[Secret administrative Subpoenas\]](#)

[6. \(1 point\) HB 2144: \(2/10/15\) Detention and removal of U.S. citizen from State; SPS shall request notification within 24 hours.](#)

[7. \(1 point\) HB 48: \(2/16/16\) Forfeiture of property used in connection with the commission of crimes; finding of guilt required.](#)

[8. \(1 point\) HB 326: \(2/9/16\) Electronic communication service or remote computing service records; obtaining records.](#)

[9. \(1 point\) HB 1428: \(2/7/17\) Absentee voting; photo identification required with application.](#)

[10. \(1 point\) HB 1598: \(2/1/17\) Voter registration; proof of citizenship required to register to vote in certain elections](#)

[11. \(1 point\) HB 1790: \(2/6/17\) Administrative Process Act; development and periodic review of regulations, report.](#)

[12. \(1 point\) SB 1195: \(2/17/17\) Produce safety; farm inspections, civil penalty.](#)
