8. [\(1 point\) HB 326: \(3/2/16\) Electronic communication service or remote computing service records; obtaining records.](#)
9. [\(1 point\) HB 1428: \(2/17/17\) Absentee voting; photo identification required with application.](#)
10. [\(1 point\) HB 1598: \(2/21/17\) Voter registration; proof of citizenship required to register to vote in certain elections - Died in Committee](#)
11. [\(1 point\) HB 1790: \(2/16/17\) Administrative Process Act; development and periodic review of regulations, report.](#)
